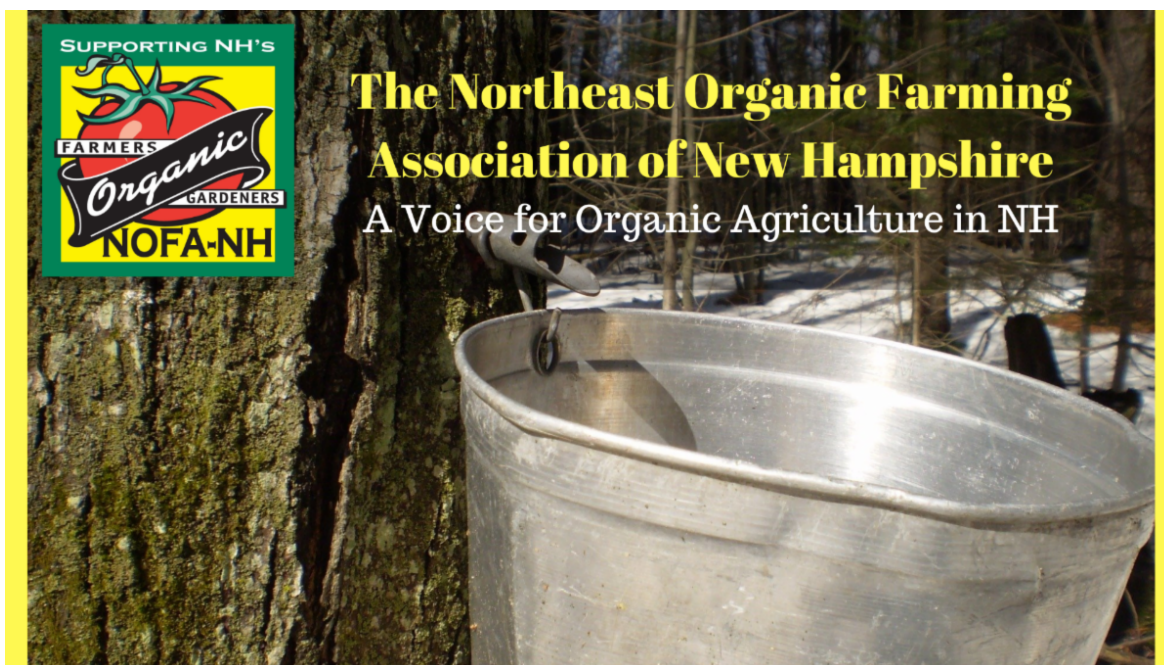

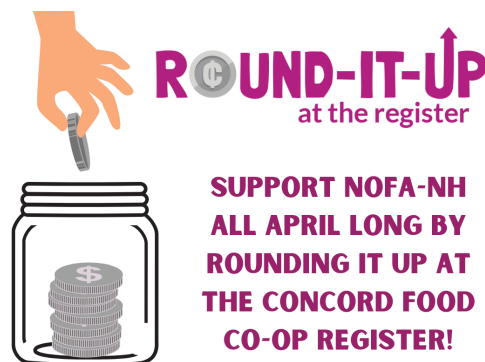
We couldn't have done it without everyone pulling together to make it happen. Well done and see you next year!

2023 Farm Bill - NOFA Priorities, NFFC Toolkit, & Climate Policy

The NOFA state chapters have developed six Farm Bill principles advocating for a Farm Bill that:

1. Invests in and protects the integrity of organic and agroecological practices as a core solution to our climate and biological crises.
2. Ensures fair treatment and just livelihoods for farmers and workers throughout the food and farming system.
3. Invests in rural communities, increases fairness and resilience of local and regional supply chains and breaks up consolidation in agriculture.
4. Centers racial justice across all programs and repairs past and ongoing racialized harm.
5. Promotes food sovereignty for disadvantaged communities and ensures nutrition security for all.
6. Eliminates the use of toxic substances on farmland and in our food system while supporting a just transition for farmers.

Shaheen Helps Reintroduce Bipartisan Bill to Support Farmers Affected by PFAS

"U.S. Senator Jeanne Shaheen (D-NH) helped reintroduce bipartisan legislation led by Senators Susan Collins (R-ME) and Angus King (I-ME), the Relief for Farmers Hit with PFAS Act, to provide vital assistance to farmers affected by per- and polyfluoroalkyl substances (PFAS) exposure.

PFAS are man-made "forever" chemicals that are used in industry and consumer products and can lead to serious health effects. PFAS contamination has prevented some farms from selling their products, creating financial hardship for affected family farmers.

"The widespread effects of PFAS contamination have dangerous implications for New England's farmers. As we work in Congress to address the full scope of this pervasive issue, providing financial relief to farmers who are navigating challenges by PFAS contamination is an important first step," said Senator Shaheen."

Free Farm Business Advising Opportunity for NH Farm & Food Businesses in Selected Counties

Thanks to grant funding from the Northern Border Regional Commission, there is an opportunity for free business consulting for New Hampshire farm and food businesses located in selected counties. Consulting can

Businesses can receive up to \$5,000 worth of consulting services at no cost to them. Work must be completed by June 30, 2023, so act now. NOSB Spring Meeting

The NOSB meets twice per year in a public forum to discuss the issues and vote on its final recommendations. The NOSB values transparency and public input, inviting both advance written and in-person oral public comments to gain additional perspectives on their recommendations. All meetings are free and open to the public, with in-person & virtual options.



This April, The NOSB will meet in Atlanta, GA to discuss substances petitioned for addition to or deletion from the National List of Allowed and Prohibited Substances (National List), substances due to sunset from the National List in 2025, and recommendations on organic policies.

The NOSB invites the public to submit written comments and/or provide oral comments at its Spring 2023 business meeting. Written public comments and requests for oral comment speaking slots must be received by 11:59 p.m. Eastern on April 5, 2023.

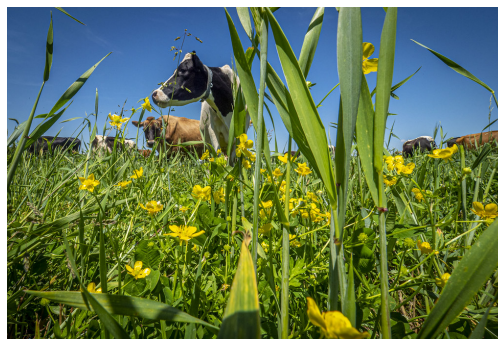
- Raise your awareness, change your understanding and shift the way you behave.

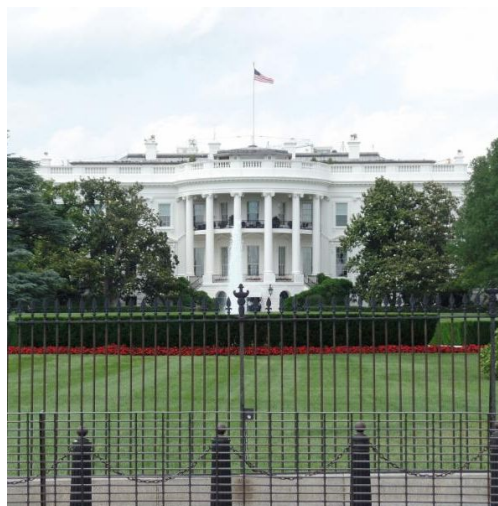
management, forage quality, environmental practices, community involvement, and public Image.

Farm and Ranch Groups Applaud USDA's "Product of U.S.A." Label Announcement

"Farm Action and American Grassfed Association applaud USDA's proposed rule limiting the use of the voluntary "Product of U.S.A." label exclusively to meat, poultry, and egg products derived from animals born, raised, slaughtered, and processed in the United States.

In 2018 while at a previous organization, Farm Action co-founders drafted a petition filed jointly with American Grassfed Association, making the legal case for the USDA to stop allowing imported meat to bear a "Product of U.S.A." label. In March 2020 and February 2022, the USDA's Food Safety Inspection Service referenced that petition as it announced it would take up the issue.

Current policy allows imported meat to bear a "Product of U.S.A." label provided it passes through a USDA-inspected plant. This heavily exploited loophole has allowed multinational corporations to import meat, repackage it, and pass it off as a higher-quality product raised by U.S. farmers and ranchers. Today's announcement is an important step toward closing this loophole, and was met with applause by the groups that initiated the effort."

March Recipe: Maple Carrot Cake

This whole foods carrot cake just happens to be gluten free, delicious and easy to make! A perfect way to highlight the coming of spring and our favorite sweet treat of the season - maple syrup!

Ingredients:

Dry Ingredients:

2 cups packed blanched almond flour
1/2 cup coconut flour
1/2 cup unsweetened shredded coconut
1 teaspoon baking soda
1 tablespoon ground cinnamon
1/4 teaspoon ground nutmeg
1/2 teaspoon salt

Wet ingredients:

4 large eggs
3/4 cup maple syrup
1/3 cup tahini
1/4 cup raw whole milk (or oat milk)
1 teaspoon vanilla extract
1/3 cup melted butter (or coconut oil)
3 cups shredded carrots
1/2 cup raisins
1/2 cup chopped walnuts

For the Frosting:

6 Tablespoons butter, room temperature
2 cups cream cheese, room temperature
1/2 cup maple syrup
2 teaspoon vanilla extract
1/2 teaspoon salt

Method:

Preheat oven to 350 degrees F. Line two 8-inch cake pans with parchment paper rounds and grease with butter or non-stick spray

In a large bowl, whisk the almond flour, coconut flour, shredded coconut, baking soda, cinnamon, nutmeg and salt together. Set aside.

In a large bowl, whisk together the eggs, maple syrup, tahini, milk, and vanilla extract until smooth. Slowly whisk in the melted and cooled butter, and then the carrots.



Add dry ingredients to wet ingredients and mix until well combined. Stir in raisins and walnuts.

Divide batter evenly between pans and spread out with a spatula to smooth the tops. Bake for 25-30 minutes. Allow to cool completely before frosting.

For Frosting:

In a large bowl, beat together butter and cream cheese with an electric hand mixer until smooth. Add maple syrup, vanilla, and salt, and beat for 2-4 more minutes.

**Optional decoration: use a vegetable peeler to peel long strips of carrot. Lightly simmer in water with a few tablespoons of maple syrup until just flexible. Cool and roll strips into rosettes.*
