LOCAL FOOD FOR LOCAL SCHOOLS REIMBURSEMENT PILOT PROGRAM MESSAGING TOOLKIT

WHAT YOU NEED TO KNOW

WHAT WILL THE BILL AND PROGRAM DO?

The Local Food for Local Schools Reimbursement Pilot Program bill will fund a pilot program to incentivize New Hampshire school districts and food service directors to purchase locally grown and produced food for breakfast and lunch services.

HOW WILL THE PROGRAM WORK?

Interested schools will apply to participate in the pilot program and, if selected, will be reimbursed for all qualifying food purchases at the following rate: \$1 for every \$3 spent on New Hampshire grown, caught, or produced foods and \$1 for every \$6 spent on New England grown, caught, or produced foods up to a predetermined dollar amount based on the school's enrollment.

Locally grown, caught, and produced foods eligible for reimbursement include processed dairy, fish, pork, beef, poultry, eggs, fruits, vegetables, cider, and maple syrup. Minimally processed proteins and minimally processed produce are also included. Fluid milk is not a qualifying food for this program. Qualifying foods can be purchased from a variety of sources, including food hubs, direct purchases from farms, and purchases through conventional distributors.

HOW WILL THE REIMBURSEMENTS BE FUNDED? In combination with federal funding, the NH Farm to School Network will utilize a state investment of \$241,000 to support reimbursements beginning with the 2024-2025 school year.

WHAT ARE THE EXPECTED IMPACTS OF THE BILL?

The NH Farm to School Network estimates the Local Food for Local Schools Reimbursement Pilot Program will annually inject \$420,000 federal and state funds directly into New Hampshire's farm and food economy.

Additionally, through the reimbursement pilot program, farm to school advocates, parents, teachers, farmers, and community members believe it will:

- Foster school-farmer relationships, lessening supply chain disruptions and increasing food security
- Increase educational opportunties and awareness for careers in agriculture and the hospitality industry
- Increase profitability for New Hampshire farmers, fishermen, and food producers




